## Annual City Clean Up Set for June 7

The annual City Clean Up will occur on Saturday, June 7, from 7 a.m. until 11 a.m. here at the St. Augusta City Hall. We are in need of volunteers from the community to help with the collection. The only requirements are that individuals be 18 years of age or older, and that they be able to assist in lifting, carrying, and handling the containers brought to the collection site. Please call City Hall at 654-0387 if you are able to volunteer to help with this.

Again this year, the charge per load/trailer will be \$8.00. Additional charges apply for appliances, electronics, tires, and the like. The charge for most appliances is \$10.00; cost for tire recycling ranges from \$1.00—30.00. Contact City Hall for a complete listing or to ask for specifics. Please also note, no gas/RV refrigerators can be accepted.

Please note, the City of St. Augusta reserves the right to refuse acceptance of any items.

Hazardous waste items will not be accepted. These include: paints, cleaners, poisons, roofing tar, fuels, automotive chemicals, sealers, garden or pool chemicals, fluorescent bulbs, adhesives, aerosols, solvents, mothballs, batteries, scrap iron, and mercury and must be taken directly to the Stearns County Hazardous Waste Facility in Waite Park.

We also cannot accept: pharmaceutical or medical waste, business waste, explosives. Also, contact Stearns County’s public used oil drop sites (listed below) to dispose of used motor oil, antifreeze, used oil filters and the like.

**PLEASE NOTE: We *cannot accept* leaves or grass clippings. We only take brush and branches. Thank you for your understanding!**

**Noxious Weeds:** The City Council along with Stearns County Highway Department is asking you to help make sure noxious weeds don't become a problem throughout St Augusta. Some to be aware of include: Blue Thistle, Canada Thistle, Plumeless Thistle, Musk Thistle, Perennial Sow Thistle, Purple Loosestrife, Field Bindweed, Poison Ivy, and Hemp. Thank you for your help in controlling these!

## Election Year Information

---

2014 is another election year. The Primary Election will be held on August 12 and the General Election will be held on November 4 at City Hall.

Elections will be for a mayor (two year term) and two city council members (four year terms)

Any eligible candidate may run for any one of the aforementioned offices by filing an 'Affidavit of Candidacy' with the Clerk-Administrator, William R. McCabe, at the St. Augusta City Hall, 1914 250th Street, along with a \$2.00 filing fee.

The period for filing Affidavits of Candidacy begins on July 29, 2014 and ends on August 12, 2014 at 5:00 p.m. Affidavits of Candidacy will not be accepted prior to or after the aforementioned filing period. 'Affidavit of Candidacy' forms are available at St. Augusta City Hall upon request.
